Objectives and Activities

The North East Mountain Trust (NEMT) is an association of climbers and hillwalkers in northeast Scotland. Its main aim is to conserve the upland, coastal and rural environments of northeast Scotland for the benefit of the public wishing to take non-motorised recreation there, both now and in the future. It acts as an umbrella group of hillwalking and mountaineering clubs.

During the year, NEMT continued to campaign on the following topics:

- Grouse moor management, focussing on the damaging effects of the trend to more intensive management, and also the illegal activities of gamekeepers. This included working with other NGOs on getting driven grouse shooting licensed.
- Deer management, focussing on the need to bring numbers down to sustainable levels.
- Developments at Cairn Gorm mountain, focussing on the need for environmental considerations to be given due weight and for a site masterplan to be published, before any further developments are carried out, to avoid further waste of public money.
- The continuing proliferation of hill tracks both for driven grouse shooting and also for the construction of small scale hydro-electricity schemes.
- The problem of excessive ATV use over unsuitable ground resulting in damage to both vegetation and soils.

We replied to the following consultations:

- CNPA Local Development Plan selected Supplementary Guidance Papers
- Strathspey Forest Local Management Plan
- Scottish Government Permitted Development Rights
 - National Planning Framework 4
 - Interim Report on Regional Land Use Partnerships

We have commented on, or objected to, a number of hill track planning applications with varying success. One highlight is that the Cairngorm National Park Authority's decision that an ugly section of illegally constructed track above the Clova Hotel must be removed was upheld on appeal. This sends a clear message that flouting the law on hill tracks will not be tolerated.

We have not objected to any wind farm planning applications in this reporting period and instead produced a wind farm policy to guide future decision making on whether to object to specific applications; the aim being to balance preservation of our mountain landscapes with the need to combat climate change.

Our programme of six winter lectures has continued to improve and was completed just before Covid-19 forced such events to shut down.

As always, a big thank you to all our members who contributed in any way, e.g. contributing to the above or writing to their local MSP on protecting mountain hares.

Report of the Independent Examiner to the Trustees of North East Mountain Trust

I report on the accounts of **North East Mountain Trust** for the year ended 30th September 2020 in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005, "the Act" and the Charities Accounts (Scotland) Regulations 2006, "the Regulations".

The Trustees consider that the audit requirement of Regulation 10(1-d) does not apply.

Respective responsibilities of Trustees and Independent Examiner

As the Trustees of the Charity, you are responsible for the preparation of the accounts. It is my responsibility under S44(1)c of the Act to examine these accounts and to report whether particular matters have come to my attention.

Basis of Independent Examiner's Report

My examination is carried out in accordance with Regulation 11 and includes a review of the accounting records kept by the Charity and a comparison of the accounts presented with those records.

It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the Trustees concerning such matters. The procedures undertaken do not provide all the evidence needed in an audit and, consequently, I do not express an audit opinion on the view given by the accounts.

Independent Examiner's Statement
