- 1. Draft AGM 2023 Minutes: These were approved, without correction.
- 2. Matters Arising: None.
- **3.** Chair's Report: There were no queries or comments on the Annual Report. The Chair said that, following the visit to RSPB Abernethy in spring 2023, he hoped to arrange a meeting with Cairngorms Connect in late March 2024.
- 4. Treasurer's Report: Alison reported that the Independent Examiner had required no changes to the accounts presented to Council in mid-December, and that therefore these and the IE statement could be signed and go to OSCR in short order. In 2022/23, Gift Aid had been claimed for 3 years; the next set of accounts would show only one year's GA. A donation had gone to the Hill of Fare Wind Farm Information Group; the Chair remarked that 2024 might see donations to both HoFWIG and to actions on masts. There were no other comments or queries on the accounts.
- 5. Appointment of General Council/Trustees: These were nominated as for 2023/24, except for Debbie Fielding who had indicated her wish to step down, i.e. as follows: Independent Member Trustees: Brian Heaton, Donald Thomas, Ken Thomson and Dave Windle. Organisations would be invited to nominate or renominate their own representatives, currently Alison Mitchell (Ramblers Scotland), Morna Harper (Aberdeen MC), Catherine Lacy-Roberts (Culter HWC), Mike Duguid (Cairngorm Club), Andy McNicoll (MBA), Roger Owen (Stonehaven HWC), Hamish Clunas (AHWC).
- 6. Appointment of Independent Examiner. It was reported that Malcolm Lamont was willing to continue as the Independent Examiner, and this was approved.
- 7. Fixing of Subscriptions of Trust Members: Alison proposed that rates should stay at their current levels, i.e. £12 per member, and 0.75p for members of affiliated clubs, subject to the £12 minimum club rate: this was approved.
