Objectives and Activities

The North East Mountain Trust (NEMT) is an association of climbers and hillwalkers in northeast Scotland. Its main aim is to conserve the upland, coastal and rural environments of northeast Scotland for the benefit of the public wishing to take non-motorised recreation there, both now and in the future. It acts as an umbrella group for local hillwalking and mountaineering clubs.

During the year, our main focus has been on continuing to campaign against the inappropriate siting of telecoms masts for the Shared Rural Network upgrade in Wild Land Areas. This has involved working with a coalition of concerned groups such as community councils and other NGOs. During the year, the campaign achieved a major victory with the UK Government undertaking a radical review of the programme and substantially reducing the proposed number of masts. During the campaign, NEMT objected to 84 individual planning applications. The outcome is a victory for common sense, directing resources to improving mobile phone signal where people live and work instead of trying to satisfy a geographical target.

Efforts have continued on the following themes:

- Peatland restoration, including several site visits to view finished work and to observe site access arrangements. We have generally found the works to be carried out to a good standard with no significant long term damage from access track construction
- Grouse moor management, including working with other NGOs to ensure that the new Government licensing regime delivers as intended.
- Deer management, focussing on the need to bring numbers down to sustainable levels.
- The continuing proliferation of hill tracks both for driven grouse shooting and also for the construction of small scale hydro-electricity schemes.
- Publicising our work via issuing our magazine Mountain Views twice a year

The year has been quiet for consultations, other than planning applications for masts, etc. We have continued to input to the FLS - Angus Glens Land Management Plan. The coming year will see us input into the next Cairngorms National Park Authority Local Development Plan.

During the year, we donated to the following causes:

- £1000 to the National Trust of Scotland for repairs to the Quoich footpath
- A further £1000 to Hill of Fare windfarm Information Group to help them prepare for the public inquiry
- £500 to the Baillies of Bennachie for footpath repairs (donation made after end of 24/25 financial year).

In the coming year, in addition to the above, we expect to increase our focus on two areas

- Inappropriately sited electrical infrastructure. This can take a number of forms: such as the proposed wind farm on the local hill, Kerloch, large pumped storage schemes and grid upgrades.
- Re-engineering rivers with heavy machinery, supposedly making them more natural

Finally, I would like to thank all of our members who have contributed in any way to the above campaigns either directly or by writing to their local MSP or MP.

Structure, Governance and Management

NEMT is a Scottish Charitable Incorporated Organisation (SCIO) under the Scottish Charitable Organisations Regulations 2011.

Trustee Appointment

NEMT is managed by a Council of not more than ten individual Members and as many representatives of Organisational Members as wish to have their representative on the Council. The overall minimum number of members of the Council shall be six.

Report of the Independent Examiner to the Trustees of North East Mountain Trust
